The two initiatives are “The Sports Wagering Regulation and Tribal Gaming Protection Act”, which can be read here and “The Tribal Gaming Protection Act”, which can be read here.</p> <p>The long form measure authorizes in-person and online sports wagering, if operated by California tribes pursuant to compacts or laws enacted by the state and approved by tribes that meet the standards set forth in the measure. The short form measure amends the Constitution of California to prohibit the legislature from authorizing sports wagering by anyone other than California tribes. The goal of the initiative proponents is to collect enough signatures and have the initiatives appear on the November 2024 ballot. Wagering could be offered no earlier than September 1, 2025. The legal age to bet would be 21.</p>

INDIANA <i>(iGaming)</i>	The long session of the Indiana General Assembly has concluded, with both chambers adjourning just before 2AM on Apr 28. Neither iGaming nor iLottery were authorized in any form during this legislative session.	Adjourned	iDEA continues to work with key legislators and stakeholders in Indiana.
MARYLAND <i>(iGaming)</i>	Nov. 15-The Maryland i-Gaming study has been completed and submitted to Maryland's Legislature. The study details the impact that iGaming in Maryland could have. It is expected that the results of this study will help form the i-Gaming bill that is expected to be introduced in the Maryland Legislature in 2024. You can read a copy of the study here . MASSACHUSETTS <i>(Sports)</i>	On July 24, Massachusetts Joint Committee on Consumer Protection and Professional Licensure held a hearing and heard testimony on S. 182. As background, this bill would make sportsbooks subject to Massachusetts deceptive advertising laws. The bill number for SD. 766 was changed to S. 182 and was then referred to the Joint Committee on Consumer Protection and Professional Licensure. More information available in the Member Portal . MINNESOTA <i>(Sports)</i>	The Minnesota Legislature adjourned without passing sports betting legislation. May 12: the Minnesota Senate Tax Committee passed the Senate sports wagering bill out of committee and sent the bill to the Senate Finance Committee. However, it is unlikely that sports betting legislation will pass in Minnesota this year. May 11: the Rules and Administration Committee reported the bill out of Committee and sent the bill to the Tax Committee.	Adjourned

NEW HAMPSHIRE <i>(iGaming)</i>	<p>Apr 26: House Ways and Means Committee unanimously recommended against passage of SB 104 (Lang). However, the bill can still be called for a vote on the House floor. As background, SB 104 would authorize online gaming in New Hampshire and direct net proceeds to a community college education scholarship fund. The NH Lottery Commission would choose online casino operators in a competitive bidding process.</p> <p>Mar 23: the Finance Committee adopted an amendment to the bill removing the legalization of online slots to address concerns from the state’s retail-based charitable casinos.</p>		
NEW JERSEY <i>(Sports + iGaming)</i> <i>(New)</i>	<p>iDEA continues to actively monitor the potential of a gaming tax increase and is working closely with various stakeholders.</p> <p>The New Jersey Speaker of the House is considering a gaming tax increase. iDEA is actively working to persuade the Speaker otherwise. The New Jersey Gaming Association is also aware of what the Speaker is considering.</p>		<p>iDEA will continue to monitor the New Jersey Legislature.</p>
NEW YORK <i>(iGaming)</i>	<p>Mar 14: Assembly and Senate released their one-house budgets; neither proposal included iGaming revenue.</p> <p>Feb 27: NY State Assembly passed A1118, sponsored by Assemb. Clyde Vanel. Proposal calls for sports betting companies to include info in advertising that highlights the potential dangers of legal gambling. Bill moved to the Senate where it was referred to the Racing, Gaming and Wagering Committee.</p> <p>Feb 15: Sen. Addabbo filed bill S4856 to legalize iGaming. The bill would offer an online license to each sports betting operator; the proposed tax rate is 30.5%.</p> <p>Feb 1: Gov. Hochul unveiled her 2024 executive budget; legal iGaming was not included.</p>		

	<p>Jan 31: NY Senate Racing, Gaming, and Wagering Committee and Assembly Racing and Wagering Committee conducted hearing on mobile sports betting. Operators testified need to lower 51% tax rate.</p> <p>Jan 17: Sen. Addabbo filed S1962 that would tie reduction in tax rate to increased number of operators. <p>NORTH CAROLINA <i>(Sports + iGaming)</i></p>	<p>NC Gov. Cooper announced that he will allow the budget to become law without his signature.</p> <p>The House and Senate have passed the budget. In the budget, there is language that requires that in order to be licensed, an operator must have a written agreement with one of the state's professional sports franchises or venues. Casinos and VGT's weren't included in the budget. We're hearing that the legislative leaders are targeting the week of October 2nd for a separate bill to address those issues. iDEA is actively engaged with the North Carolina Legislature on these issues.</p> <p>As of September 15, no final vote on the budget has taken place and negotiations are ongoing.</p> <p>NC's Governor and Legislature is attempting to insert land-based casino and VLT licenses in the state budget. iDEA is already at work to have iGaming included in the budget as well. The casinos and VLT's have been lobbying this behind the scenes for the past few months and the VLT lobby is trying to make sure that iGaming legalization doesn't make it into the budget.</p> <p>June 14: Governor Cooper signed H 347 into law. 	<p>June 7: NC House concurred with changes made by the Senate to the sports betting bill. The bill now heads to the Governor; anticipated he will sign.</p> <p>June 1: H 347 passed out of the Senate. Since changes were made in the Senate, the bill goes back to House for a concurrence vote. Sports betting will launch no later than 12 months after the bill becomes law.</p> <p>May 24: the Senate Committee on Commerce and Insurance amended and then reported H 347 to the Senate Committee on Finance. Among the changes is increasing tax rate to 18%.</p>		
<p>OHIO <i>(Sports)</i></p>	<p>OH's final budget includes increased sports wagering tax rate of 20%.</p> <p>The Ohio budget conference committee started on June 22. The House is fighting hard against the 10% tax increase.</p> <p>June 15: the Senate passed their version of the budget (includes the increased sports gaming tax); now heads to a conference committee.</p> <p>The Senate's substitute budget bill reinstated Gov. DeWine's proposed doubling of the sports gaming tax from 10% to 20%. With education budget negotiations being an intricate part of the process, we have been informed that a deal has been struck on education and the funding will come from either the Rainy Day Fund and the extra revenues the state has from what was originally projected in the budget estimate.</p> <p>In his recommended two-year state budget proposal (line 73672), Gov. DeWine proposed doubling the tax on sports betting from 10% to 20%.</p>		<p>iDEA will monitor the activity of the Ohio legislature.</p> <p>On June 27, iDEA General Counsel, Jeff Ifrah sent a letter to members of Ohio's HB 33 Conference Committee with recommendations related to the state Senate's proposed tax increase on sports betting. <p>OKLAHOMA <i>(Sports)</i></p>	<p>Oklahoma Governor Kevin Stitt announced his proposal for sports betting in Oklahoma. The proposal will have retail sports betting conducted by federally recognized Oklahoma tribes. The tax rate will be 15%. Tribal sports betting will be pursuant to a state-tribal gaming compact. Online sports betting will be offered by licensed sports betting operators. Operators would pay an initial licensing fee of \$500,000 and be required to pay an annual licensing fee of \$100,000. The tax rate will be 20%. You can read a fact sheet on the Governor's proposal here.</p>		

<p>RHODE ISLAND <i>(iGaming)</i></p>	<p>RI's Governor has signed the iGaming bills, which take effect on March 1, 2024.</p> <p>June 13: the House Finance Committee recommended passage of substitute B for S 948. On the same day, the House Finance Committee amended the House version of the iGaming bill, H 6348 and recommended passage. The bills mirror each other.</p> <p>June 15: the House passed both substituted bills. The Senate concurred with the changes to the Senate bill and passed the House bill. Both bills have been sent to the Governor. If signed into law, the bills will take effect on March 1, 2024. Note: While only one of these bills must go through the entire legislative process to become law, in Rhode Island, it is not uncommon for both the identical Senate and House versions to be enacted into law.</p> <p>June 6: the Senate Special Legislation and Veterans Affairs Committee recommended passage of bill substitute A for S 948 (a bill that would legalize iGaming) and placed the bill on the Senate calendar.</p> <p>June 8: the Senate passed the substitute bill A.</p> <p>May 10: Hearing on S 948 in Senate Special Legislation and Veterans Affairs Committee; Committee recommended the bill be held for further study.</p> <p>Apr 27: State Senate President Dominick Ruggerio filed S 948, a bill to legalize iGaming. The legislation would allow the state's Division of Lotteries to authorize online slots and table games at Bally's retail casinos in the state.</p>		
<p>VERMONT <i>(Sports)</i></p>	<p>June 14: Gov. Phil Scott signed H 127 into law. The Vermont Department of Liquor and Lottery will be the regulatory body that oversees sports wagering. It is expected that sports wagering will launch by January 2024.</p> <p>May 9: VT House concurred on changes made by the Senate to the sports wagering bill. The bill now heads to Gov. Phil Scott, and it is anticipated that he will sign.</p> <p>May 3: the Senate passed H 127 (Birong) with various amendments that do the following:</p>	<p>Adjourned</p>

Sept. 7: Retail sports betting launched.

The initial sports wagering catalog has been released. A copy of it can be found [here](#). This initial catalog will be effective for the opening of retail sports wagering on Sept. 7.

Aug. 22: The Kentucky Horse Racing Commission (KHRC) voted to approve temporary licenses for sports wagering operators and service providers.

A Sports Wagering Advisory Council has been formed. The council will advise the full commission and provide additional voices who have direct knowledge of the sports betting industry.

Per KHRC, Kentuckians can pre-register an account with approved mobile applications on Aug. 28, at 6 a.m. EDT.

KHRC announced that licensing applications are being reviewed and will be voted on at a meeting of the full commission on August 22.

Kentucky's emergency sports wagering regulations were passed; effective July 10. A summary of the regulations and info on public hearing and comment period, along with links and contact info for license applications is available [here](#).

Retail go-live is Sept 7, 2023 at 10am EDT; online go-live is Sept 28, 2023 at 6 am EDT.

Initial intel indicates there will be emergency rules and they will allow operators currently licensed in other states to operate in KY. The Gov is pushing hard to launch before NFL 2023 season.

Because several horses died at Churchill Downs, the venue closed and the Kentucky Horse Racing Commission temporarily delayed work on the sports wagering regulations.

	<p>Kentucky’s sports betting bill – HB 551 (Meredith) will become effective on Jun 28; KHRC will then have six months from that date (until Dec. 28) to promulgate regulations, although it is expected that the rules will be drafted much sooner.</p>		
<p>MAINE <i>(Sports)</i></p>	<p>Maine sports betting is live, as of November 3rd. Maine has released the final regulations governing sports wagering. You can read them here.</p> <p>The final sports wagering regulations are expected to be issued on November 1st. We expect no significant changes were made to the last version of the proposed regulations. The Gambling Control Unit expects to issue temporary licenses soon after the regulations get published.</p> <p>The Executive Director of Maine’s Gambling Control Unit, Milton Champion, stated that the Attorney General plans to complete their review of the final draft regulations by early November. The Secretary of State will then need to adopt the rules, which should occur shortly after the AG’s review is completed.</p> <p>The final regulations are getting closer to being issued; potentially in October. It is not expected that there will be significant changes from the last version of proposed regulations. The plan is still to issue temporary licenses on the same day as the final regulations.</p> <p>The sports betting rules have been submitted to the AG’s office for review and are expected to be approved in November. Sports betting licenses will be issued on the day the rules are approved.</p> <p>May 17: Maine's Gambling Control Unit released new proposed regulations governing sports betting; substantial revisions were made. The hearing will take place on Tuesday, December 5, 2023, at 9:30 AM EST.</p> <p>Oct. 19- The MGC gave final approval to the Temporary Licensing Procedures and Renewal of a Sports Wagering License regulations.</p> <p>The MGC announced a public hearing on October 10, 2023 at 9:30 am on 205 CMR 219-Temporary Licensing Procedures and 205 CMR 231-Renewal of a Sports Wagering License.</p> <p>The MGC will accept comments on the two regulations through 5 pm on Monday, October 9, 2023.</p> <p>Aug 24: The MGC voted to issue a waiver to the data privacy regulation until November 17, 2023. During the waiver period, operators are asked to provide further details and implementation plans/timelines for meeting the requirements. Both sets of regulations are now in effect.</p> <p>The Notice of Adoption for the two regulations that were recently approved by the New York State Gaming Commission (interactive fantasy sports and sports wagering advertising and marketing), weren't included in this week's New York State Register.</p> <p>Oct. 3: The New York State Gaming Commission approved two sets of proposed regulations during their monthly meeting. The first, which relates to interactive fantasy sports, was approved as published. The second, relating to sports wagering advertising and marketing, was also approved with a few minor changes made to the regulation. The Notice of Adoption of both sets of regulations will be published in an upcoming edition of the New York State Register, at which point they will take effect.</p> <p>Aug 4: This week's New York State Register included two gaming-related regulatory proposals.
